### Milwaukee-Area Phone numbers, Hotlines, Email Addresses, and Websites for COVID Vaccine Information and Appointments

While most major health systems have asked those eligible for a vaccine <u>not</u> to call their doctor's offices and hospitals — and instead wait to hear from them — some vaccine providers have set up vaccine information and registration hotlines for those who might not have an internet connection, a smartphone or an email address.

Below is a list of phone numbers, email addresses, links, and directions on how to register for a vaccination appointment at Milwaukee-area health departments and health systems.

### Milwaukee County

Milwaukee County's website, <u>HealthyMKE.com</u>, allows residents to sign up for vaccine updates as well as get connected with a vaccine provider.

- You need both an email address and phone number to register online.
- If you do not have both an email and a phone number, call the vaccine hotline at (414) 286-6800 or 211 to register.
